Privacy Consent Form

Introduction

This Privacy Consent Form ("Form") describes how International School of Qingdao (the "School") collects, uses, shares and retains the personal information provided by students, parents/guardians, and prospective job applicants (collectively referred to as "Individuals"), and informs Individuals about their rights and choices regarding their personal information.

The School only collects and uses personal information for education-related purposes such as student management, teaching, academic evaluation, and other school activities. The School does not process personal information for any unrelated commercial or other purposes.

Personal Information Collected

The School may collect the following categories of personal information:

Necessary Information: Such as name, student/parent ID, date of birth, gender, contact details, etc. needed for basic student/job applicant management.

Academic Information: Such as test scores, assignments, course selection, grades, comments from teachers, etc. needed for teaching and studies.

Voluntary Information: Such as hobbies, interests, extracurricular activities, photos, etc. provided optionally by Individuals.

The School will explicitly obtain consent from Individuals before collecting any sensitive personal information such as ethnicity, religion, biometrics, medical conditions, etc.

Personal Information Processing

The School only processes personal information based on legal basis or consent from Individuals. No automatic decision making is carried out. The School will not provide any personal information to overseas organizations without obtaining prior consent.

Rights of Individuals

Individuals have rights such as access, rectification, erasure, objection to processing of their personal information. They can withdraw consent at any time. Please contact the School's Data Protection Officer for exercising these rights.

Data Protection Responsibilities

The School and its Head of School are responsible for protecting the personal information, adhering to this Form and applicable privacy laws.

School Activities Agreement

学校活动协议

학교 활동 계약

This Agreement applies to the enrollment of the child or children named below (your children) of the undersigned parents or legal guardian (you) in International School of Qingdao (ISQ, formally Qingdao Zhuoyi Foreigner's Children School), a Chinese school for the children of expatriates. ISQ was founded and registered as an independent legal entity in Qingdao, Shandong Province, China, in accordance with relevant PRC regulations, for the benefit of the public. Accredited by Cognia as a LifePlus international school, and an independent legal entity, ISQ is solely responsible for the provision of educational services to your enrolled children. We make the utmost effort to provide a safe and secure environment for our students in all of their school-related activities, in compliance with the Law and School Regulations.

1. Assumption of risk

Telephone contact may not prove possible due to the deficiencies in the communication system in China and between other countries and China. You hereby authorize ISQ personnel to provide first aid treatment and to transport your child to a medical treatment facility if needed. You also hereby authorize ISQ personnel to make decisions about medical treatment for your child if you or your Emergency Contact are unavailable or unable to make these decisions for any reason. ISQ disclaims any responsibility for any actions or inactions of the medical personnel or medical facility in treating your children. You agree that ISQ and its board members, officers, employees, and volunteers and its employees and agents are hereby released and forever discharged and

3. Medical and other forms of insurance

ISQ does not maintain and is not able to provide insurance for student participants in these activities or other school activities, such as standard health, medical, or disability policies. You are expected and encouraged to obtain your own medical or health insurance coverage for your children and for yourselves. The school does purchase Travel Accident insurance for school trips, which provides nominal coverage for emergency medical care and disabilities resulting from injury during school related travel. You are encouraged to obtain supplemental insurance for your children that you deem sufficient to cover the range of potential losses during travel, including trip cancellation, loss of luggage, injury, medical care, and emergency repatriation expenses.

8. Liability release

ISQ and its board members, officers, employees, volunteers and agents are hereby released and forever discharged and held harmless from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from the participation your children in these activities, including field trips, that are normally organized under the Law and the School regulations by ISQ—unless it is determined under the laws and regulations of the PRC that ISQ personnel were negligent in the case of personal injury or acted intentionally or with gross negligence in the case of property damage, but only to the extent that their actions or inactions caused the injury or damage.

责任免除

9. Scope of releases/severability

The provisions in this Agreement concerning assumption of the risk, disclaimer of liability, and release of claims are intended to be as broad and inclusive as permitted by the laws of the People's Republic of China and shall be so interpreted by any tribunal that may be called upon to review its terms. In the event that any clause or provision of this Agreement shall be held to be invalid in a judicial proceeding, the invalidity of such clause or provision shall not diminish or affect the remaining provisions of this Agreement, which shall continue to be enforceable.

免责的范围或可分割性

면책 범위/분리가능성

본 협약서에는 위험 감수, 책임 면제, 면책조항이 포함되어 있으며, 중화인민공화국의 법률이 허용하는 범위에서 협약의 규정은 광범위하고 포괄적으로 되어 있습니다. 법원 재판시 협약서의 조항에 대해서는 법원의 해석을 따릅니다. 협약의 특정 조항이나 규정이 사법 절차 중 무효로 간주되는 경우, 이는 협약의 나머지 조항에 대해서는 영향을 끼치지 않으며, 나머지 조항은 계속해서 법적 구속력을 가집니다.

10. Limitation of liability

If ISQ or its directors, officers, employees, or volunteers should be found liable for any physical injury, property damage or loss, or any other loss experienced by your children or you, it is agree that the payment required from ISQ shall be no greater than the amount normally awarded by a Chinese District Court in the City of Qingdao for such injury, damage or loss, based on the Law and regulations of the PRC.

责任的限制

11. Arbitration of disputes

Any dispute arising from or in connection with this Agreement or the enrollment of your children at ISQ shall be submitted to the China International Economic and Trade Arbitration Commission (CIETAC) Beijing Sub-Commission for arbitration which shall be arbitrated in the city of Beijing in accordance with CIETAC's arbitration rules in effect at the time the application for arbitration is filed. The arbitration shall be by 3 arbitrators and the arbitral award is final and binding upon all parties to the arbitration. By mutual consent, you and ISQ may agree to arbitration or conciliation in a different manner or place.

争议仲裁

任何由此协议引起或与此协议相关的纠纷，或您的孩子在 ISQ 报名中引起的纠纷，应提交中国国际经济贸易仲裁委员会 (CIETAC) 北京分会，按照仲裁申请时中国国际经济贸易仲裁委员会现行有效的仲裁规则进行仲裁，仲裁地为北京市。各方同意由三名仲裁员仲裁，仲裁裁决具有终局性，对各方均有约束力。只有在双方共同认可下，您和 ISQ 才可以用其它方式或在其它地点仲裁或调解。

분쟁의 중재

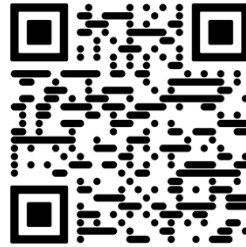
